There have been multiple issues we have dealt with this month because of weather, Holidays, and power outages but staff has once again stepped up to support each other and provide uninterrupted water and sewer service.

I have been working with staff and community members to identify areas of concern with the water and sewer service infrastructure. Through much investigation we have been developing an infrastructure replacement plan.

There has been a lot of interest with the Jesse Jefferies complaint about the Humboldt County Road Department using water from their property to do road repairs, so I have been communicating with the State Water Board, Humboldt County officials and attorney's to investigate this complaint.

I have been working with developers who have projects in progress to implement upgrades which will benefit GSD while providing water and sewer service to their projects.

GENERAL OVERVIEW AND FINANCIAL CONSIDERATIONS

The attached Financial Statements are for October 2019. The final audit entries have been made and these are a final version.

As can be seen on the "Statement of Cash Flows Report for Board - October 2019" and the "Balance Sheet Report for Board As of October 2019":

- In general water revenues are under budget (\$9,730 shortfall) and getting worse each month, expenses are over budget, plus the purchase of the truck has resulted in a significant negative cash flow.
- Net <u>cash</u> DECREASE for October is (\$1,634.35), and the year to date cash DECREASE is (\$48,033.19). This is made up of mainly the purchase of the utility truck. The negative cash flow not including the truck is (\$7,998.86).
- Expenditures for <u>fixed asset</u> acquisition so far this year total **\$ 45,716.13**.
- Total payments on <u>loans</u> so far this year total **\$41,679.32** of an expected year-end total of \$164,903.
- Total payroll costs are just slightly higher than the YTD budgeted amount.
- The <u>overtime</u> wages are **\$5,397.46** higher than the YTD budgeted amount and are growing.
- The <u>repair and maintenance</u> expenses are way over the YTD budgeted amount. The overage is because of a water leak at Conger & Redwood that needed to be fixed and the installation of water valves at the location. Should no further large R&M expenses be incurred, then the annual total at the end of the year should be under the final budget.

Foundation proposals included precast concrete pile, deep and large diameter (150-200 ft deep and greater than 8 ft in diameter) cast-insteel-shell (CISS) pile, and cast-in-drilled-hole (CIDH) pile.

Dan's involvement was during the D-B Team selection process and included performing reviews of the D-B proposals in the areas of structure constructability, management / administration, including Quality Management Plan assessments, and construction schedule analysis.

I-5 Boat Section thru Downtown Sacramento, Sacramento County, CA I-5 thru downtown Sacramento is depressed below the level of the adjacent Sacramento River. The roadway is held in place against buoyant forces by tension piles and the deadweight of a concrete tremie seal. The travelled way is a structural section similar to a bridge deck which "floats" on top of the tremie seal. A complex drainage system directs surface water to a pumping system which pumps to the Sacramento River.

This structure portion of this project involved a \$20.4 Million replacement of the travelled way and drainage system, a polyester concrete overlay, and standby generator building. This work was done in an accelerated manner with full freeway closures for up to 1 week at a time and the necessary detours. Dan's involvement included: Providing interpretation of contract plans and specs and monitoring compliance thereof, provided assistance in resolving project problems, issues and claims resolution, providing supervision, coordinating with Caltrans design and maintenance units to quickly resolve construction issues, staffing and assisting with 24/7 field inspection activities including profilographing the finished travelled way and interpretation of the profilograph traces.

Confusion Hill Realignment Project [CIP Segmental Bridge], Mendocino County, CA Dan was responsible as the Area Manager on this project, where his personal responsibilities included but not limited to: Providing oversight of interpretation of contract plans and specs, and monitoring compliance thereof. Dan ensured that the project records were kept in accordance with Caltrans policies and procedures, provided assistance in mass concrete implementation and in resolving project problems, issues and claims resolution. Dan assisted in ensuring that environmental laws and permits are observed, prepared performance evaluations and provided supervision and moral support to personnel for effective delivery of the project.

This \$37 M Ten-Mile Bridge Replacement Project involved the construction of a new bridge in a new alignment and the demolition of the existing bridge once the replacement structure has been placed ein service. The new structure is an 8-span, 1,702-foot long CIP pre-stressed box girder bridge built on an environmentally sensitive river bearing the project's name. Foundation work oversight involved concrete in steel shell driven to specified tip. Extensive acoustic monitoring was employed to ensure protection of three listed species of fish (Chinook salmon, steelhead, tidewater goby).

Hardscrabble Creek Bridge Replacement Project, Hwy 199, Del Norte County, CA Dan was responsible as the Area Construction Manager on this project, which was an Accelerated Bridge Construction project, where his personal responsibilities included but not limited to: Providing interpretation of contract plans and specs and monitoring compliance thereof. Dan ensured that the project records were kept in accordance with Caltrans policies and procedures, and provided assistance in resolving project problems, issues and claims resolution. Dan assisted in ensuring that environmental laws and permit requirements were adhered to. Dan prepared performance evaluations, providing supervision and moral support to personnel for effective delivery of the project.

The \$1.3 M Hardscrabble Creek Bridge was a 154-foot single span CIP pre-stressed concrete box girder bridge constructed in an accelerated technique using "Build and Slide" strategy. The work involved casting the new superstructure on temporary abutments, diverting traffic onto the new superstructure while the old bridge was demolished and the new abutments were being constructed. Once the new abutments were completed, the highway was closed for 6 hours and the new superstructure was then slid into place, onto the new abutments.

Coon Creek Bridge Replacement Project, Hwy 169, Humboldt County, CA Assigned as Resident Engineer and Structure Representative on this 900 ft long reinforced box girder bridge, a 200 ft long tieback wall with CIDH soldier piles, and approaches. This bridge was complicated as it crossed a deep gorge with two level falsework and was on a 300 ft radius with a 9% cross slope.

Scotts Creek Bridge Replacement Project, Hwy 20, Lake County, CA Assigned as Resident Engineer and Structure Representative on a 5-span cast-in-place post tensioned box girder bridge constructed in two stages, along with the approaches. On this project Dan took the initiative to accelerate the closure pour between stage one and stage two bridges by monitoring the settlement of both stages and writing a Contract Change Order to allow an early closure pour.

70/99 I/C, Cross Canal Bridge, & Howsley Rd UC, Hwy 99 & 70, Sutter County, CA Dan assumed the Structure Representative responsibility for the completion of this project when remaining work including a cast-in-place post tensioned voided slab bridge and a pump station. During construction, the existing piles at Cross Canal Bridge were undermined and the bridge settled 3 inches. Dan designed a strong back support system, and then monitored jacking this bridge back to profile and Dan designed a new foundation for the effected bents.

Mokeleumne River Bridge Widening Project, Hwy 99, San Juan County, CA Dan was responsible on this project as the designated project Structure Representative. This project included connecting the existing piers and footings with new piers and footings. One challenge that developed was that the tremie seal from the existing footings interfered with the cofferdams for the new work. Dan facilitated a design change to separate the new and existing sufficiently to allow placement of the cofferdam. Dan implemented procedural changes to the Caltrans Bridge Construction Records & Procedures Manual to ensue future as-built plans would reflect tremie concrete left in place.

Additional Relevant Experience

Dan served as the Caltrans Office of Structure Construction Safety Liaison on the AGC-Caltrans Safety Committee, Structure Construction CCO desk reviewing all Structure Construction related change orders statewide for uniformity and trends that might require specification or policy changes, structure type selection and strategy meetings, and other Caltrans-Structure committees, including Segmental Bridge, Loads, and Coatings, authored the OSC <u>Shotcrete Inspectors' Guide</u> and represented Caltrans on the ARTBA-AGC Task Force that developed guidelines for shotcrete use on structures to be used by inspectors as well as specification review & development, this effort resulted in publication of the AASHTO <u>Inspector's Guide for Structure Repairs of Bridges</u>. The District will review the protest applications and must provide responses within 60 days. The goal is to resolve the specific issue(s) presented by the applicant in the main protest letter. For some concerns (such as that the SHCP should be publicly owned) there may not be a resolution available, but the District will provide a response to the protestor. The SWRCB-DWR will step in after 180 days from the date the notice closed if the District and the applicant cannot come to a resolution. SWRCB-DWR will be copied on the responses to the protestors and will guide the District through the process should more than one response be necessary.

As part of the LAFCo action, the SHCP and GSD have been required to execute an Annexation Consent Agreement & Covenant document which will be recorded against the SHCP property. The SHCP has requested that the verbiage lined out below be removed from the agreement before they approve and execute the agreement.

"1. Consent/Petition to Future Annexation or Reorganization. Owner hereby irrevocably consents to and petitions for the future annexation of his or her property to the Garberville Sanitary District and agrees to cooperate in such annexation upon the District's or LAFCo's request, including the payment of applicable processing fees for the annexation of the Property. Owner understands and agrees that this consent/petition to annexation includes all obligations attendant upon annexation, including all taxes, assessments and fees that the District imposes upon property within the District. "

These processing fees would only be associated with an annexation that was not requested by SHCP. For any annexation that was a result of SHCP desiring to change the locations, quantity or type of use as listed in the Water Service Agreement, the SHCP would still be responsible for reimbursement of fees as negotiated at that time.

FINANCIAL CONSIDERATIONS

The responses to protestors and associated coordination with the protest applicants will be costly. These costs will be borne by the SHCP and will be added to the balance due on the quarterly statements to the SHCP as the expenses are incurred.

RECOMMENDED BOARD ACTIONS

- 1. Approve the recommended change to the ANNEXATION CONSENT AGREEMENT AND COVENANT as shown above.
- 2. Direct staff to coordinate for the preparation of responses to the four protests.

This letter is in response to notification from the State Water Resources Control Board regarding Petition for Change for Water Right License 3404 (Application 9686) and Permit 20789 (Application 29981) of Garberville Sanitary District. During the regularly scheduled business meeting on November 20, 2019 the Redway Community Services District (Redway CSD) Board of Directors directed staff to write a letter of protest to your office that includes some key points. This is that letter. The Protest Application form is enclosed.

The Southern Humboldt Community Park (Park) is a private non-profit, not a public agency. As such, the Board of Directors of the Park hold private meetings that are not open to the public. And therefore, the motivations of the Park are not clear to the general public and do not necessarily represent the public interest. Many members of the larger community of southern Humboldt County support the park and many do not. Those that do not support the Park and its activities cite the closed meetings and methods by which the Park has obtained property and financial support among other special interests.

During the application to the Humboldt Local Agency Formation Commission (Humboldt LAFCo) comment period for this out of district service, Redway CSD wrote a letter to Humboldt LAFCo indicating that the Redway CSD Board of Directors has reservations about GSD providing this out of district connection to the Park because this connection may not be in the public interest. That letter was not included by GSD in their petition to the State Water Resources Control Board and the Redway CSD Board of Directors feels that it should have been for the sake of transparency. That letter to the Humboldt LAFCo is enclosed with this letter.

The Redway CSD Board of Directors feels that there are other ways to provide potable water to the Park. A formal annexation of the Park property to the GSD would require that the Park be subject to all of the ordinances of the GSD. Additionally, this would make the Park's activities more transparent to the public because building permits would be referred to GSD and their Board of Directors when the Park modifies land use, structures and other improvements. Another option would be for the Park to become a recreation district which would provide for public ownership and, therefore transparency. The final comment that the Redway CSD Board of Directors would like communicated is that they support public space and that aspect of the Park's activities. That they do not support the private ownership and special interests of the Park or its Board of Directors and do not believe that this out of district connection is in the public interest.

My concern about this request by GSD to serve water to the Southern Humboldt Community Park(SHCP) is that it is not about people discarding plastic water bottles on public property. (The SHCP is private property.) Most people do not mind bringing in their own water bottles to this private Park. This Petition for change in the GSD Place of Use requests a significantly larger "island of service" than the one described in 2012-13 GSD Annexation. It requests more water in more areas of the Park than ever before. It sets up water spigots in each of the commercially zoned areas of the Park. These are zoned Public Facilities, (PF) which allows for heavy impact uses. The PF zones mapped out in the Park's EIR are for concerts and festivals, public restrooms, campgrounds, a public meeting center, a sports center and ball fields. My concern is that piping GSD water out to all these areas of the Park creates the opportunity to use it for PF purposes without any CEQA review or mitigations to possible significant impacts. Strict legal enforcement wording that will hold up in court is needed to support the limits placed on the proposed 2999 cubic ft. per month connection.

The Application from GSD now before you contains Resolution 19-02. This is a Resolution that seems like the one that GSD offered to the Park in 2012. But it is significantly different. GSD has changed the wording in Resolution 19-02 and it does not match the original 2012 "island of service" offer which designated that the GSD water connection be for "residential use only". The new wording blurs the boundary between residential use and commercial use of GSD water on the SHCP property. It opens the door to possibly significant impacts to the South Fork Eel river, its wildlife, its threatened aquatic species, and its stability and dependability as a drinking water source for the communities of Garberville and Redway. And yet, to date, these impacts have not been analyzed under CEQA. The (OAS) out-of-area service connection that GSD is specifically requesting does not address these concerns.

The river is the source of drinking water for over a thousand ratepayers in the Garberville Sanitary District and downstream, in the Redway Community Services District. An "out of area service connection" with no true site specific CEQA, is not adequate to meet the responsibility GSD owes to ratepayers and threatened species who need a river that can last through droughts and very low flows in summer. The SHCP Park is already taking at least 7 million gallons out of the river for private lease crops, wine grapes and cattle-raising without a meter on their riparian intake line. They approximate this figure. The current applications by new businesses for even more high volumes of water are increasing in Garberville. One of the most important projects that must be addressed is the 2030 new hospital which will consume at minimum five million gallons a year according GSD's consultant, 4JS Consulting, Jennie Short. Other projects in GSD's pipeline include many more legal marijuana growers, the renovated Six Rivers Bank building on Redwood Drive, the bubble hash processing plant going in on Redwood Drive, and a lifestyle spa motel next to the Highway 101 at the north end of Garberville. These businesses are lining up for water service at a time that the Garberville Sanitary District is already using over 70 million of the 80 million gallons it is allocated yearly from the State. A complete GSD capacity study and a proper, (not a "piecemealed" addendum) CEQA is needed that accounts for all of the upcoming projects and their impacts on the South Fork Eel river before a decision is made on this change in place of use. Please do not rush into this decision. It needs time for your deliberation. Thank you for your work.

Like the fable of the blind men and the elephant, CEQA's prohibition on "piecemealing" of environmental review is animated by a basic recognition that the "whole" of an action under review is greater than its individual parts viewed separately. (The same important insight also underlies CEQA's requirement to analyze a project's cumulative impacts.) But CEQA's expansive and rather amorphous definition of what constitutes a "project" ensures that its piecemealing rule shares another similarity with the famous fable: what conduct constitutes improper piecemealing often appears to be in the "eye of the beholder" and individual perceptions can differ greatly based on more-or-less subjective factors. Appellate courts have long wrestled with application of the relevant legal principles, which essentially attempt to prohibit a lead agency's "chopping up" of a project into smaller components so that it can turn a "blind eye" to reasonably foreseeable environmental impacts of the "whole" action.

The reason I bring this to your attention, this CEQA addendum you have before you for this Change Petition is the CEQA textbook example of "piecemealing". This metered water service connection from GSD, that would need your approval to expand GSD's diversion Place of Use, as proposed, was not reviewed, studied or analyzed under CEQA. Nor was it analyzed within the initial study for the Garberville Sanitary District (GSD) IS/MND Annexation (SCH # 2012032025) or the Southern Humboldt Community Park (SHCP) DEIR or Final EIR (SCH # 2010092037). What you have before you has been "piecemealed" between these two CEQA documents and submitted to you only as a narrative that was not analyzed as a whole under CEQA as referenced in this Petition. In other words, what you have is a bait and switch approach to CEQA. All you need to do is review and read each CEQA document (SCH # 201009037 & SCH # 2012032025) to understand this addendum is circumventing the CEQA process and my comments 1 thru 11 will help guide you through my argument and why I am opposed to this addendum being used.

The State CEQA Guidelines define a project under CEQA as "the whole of the action" that may result either directly or indirectly in physical changes to the environment. This broad definition is intended to provide the maximum protection of the environment. Piecemealing or segmenting means dividing a project into two or more pieces and evaluating each piece in a separate environmental document, rather than evaluating the whole of the project in one environmental document. This is explicitly forbidden by CEQA, because dividing a project into a number of pieces would allow a Lead Agency to minimize the apparent environmental impacts of a project by evaluating individual pieces separately, each of which may have a less-than- significant impact on the environment, but which together may result in a significant impact. Segmenting a project may also hinder developing comprehensive mitigation strategies. In general, if an activity or facility is necessary for the operation of a project, or necessary to achieve the project objectives, or a reasonably foreseeable consequence of approving the project, then it should be considered an integral project component that should be analyzed within the environmental analysis. The project description should include all project components, including those that will have to be approved by responsible agencies. When future phases of a project are possible, but too speculative to be evaluated, the EIR should still mention that future phases may occur, provide as much information as is available about these future phases, and indicate that they would be subject to future CEQA review. CEQA case law has established the following general principles on project segmentation for different project types:

For a phased development project, even if details about future phases are not known, future phases must be included in the project description if they are a reasonably foreseeable consequence of the initial phase and will significantly change the initial project or its impacts. Laurel Heights Improvement Association v Regents of University of California (1988) 47 Cal. 3d 376.

For a planning approval such as general plan amendment, the project description must include reasonably anticipated physical development that could occur in view of the approval. City of Redlands v. County of San Bernardino (2002) 96 Cal. App. 4th 398.

For a project requiring construction of offsite infrastructure (e.g., water and sewer lines), the offsite infrastructure must be included in the project description. San Joaquin Raptor/Wildlife Rescue Center v. County of Stanislaus (1994) 27 Cal.App. 4th 713.

For modification of a permit for an existing facility, the scope of the project description can be limited to the scope of the permit modification and does not cover the entire facility. Citizens for East Shore Parks v. State Lands Commission (2011) 202 Cal.App. 4th 549.

1. Nothing included in the SHCP Final EIR addressed, analyzed or mitigated the existence of past or future water service from GSD. In fact, it's stated in the addendum, page 16: "However, the 2016 EIR did not consider potential connection to GSD for potable water supply". Items included in this addendum have been cherry picked and "piecemealed" only using selected parts of the SHCP EIR, then cobbled together using selected parts of the GSD Annexation IS/MND. for which this addendum was created and embellished.

2. Just because the GSD included the SHCP project in GSD Annexation IS/MND as an informational item only, i.e. "Other Projects in the Garberville Area", does not mean it addressed, studied or analyzed under CEQA, because it was not. In fact, as of June 18, 2019, GSD has now increased the area to be served with this new water service connection (Place of Use) within the SHCP property, compared to what was only mentioned in the GSD Annexation IS/MND. GSD has increased the area of use by more than 3 times and added more access and use of water for non-residential and non-domestic use in those new designated areas within the SHCP property boundary, that are only intended for private commercial events, public assembly, fundraisers, concerts, festivals, new private development and now allowing 800 to 5000 visitors a day per event. How were these changes analyzed under CEQA in the GSD Annexation IS/MND? Answer: They were not.

3. In the SHCP Final EIR response to comments, it was made abundantly clear, the only use and source of water intended for use on the SHCP property came from the SHCP's own private onsite water sources, "adequate supply of potable water", it did NOT include a water source from GSD.

4. As Jennie Short stated, addressing the GSD Board on June 18, 2019; she acknowledges the elephant in the room: *"The fact that GSD as a water source was not included in the Park's EIR was unfortunate and that would have been ideal if that had been done."*

5. As explained from the SHCP FEIR Response to Comments to the DEIR (SCH# 2010092037), in part they state and confirm the following:

(a) Re: LETTER B3 Humboldt Local Agency Formation Commission B3-1

"The commenter correctly describes much of the history of the potential annexation of the project site into the Garberville Sanitary District (GSD). However, since the site was excluded from the 2014 annexation process by GSD, the project applicant has moved on to address the park's water needs. The applicant completed a water supply and demand analysis, which showed there are adequate water supplies within the control of the applicant to develop the project. Further, the project includes a proposal for the use of an upland well as part of the overall water supply strategy. Water withdrawn from this well would not affect flows on the South Fork Eel River, which would be the case for water supplied from GSD. Thus, the proposed system of providing water from a range of sources available to the applicant is more environmentally beneficial, and annexation to GSD is not necessary."

(b) Re: LETTER B4 Garberville Sanitary District B4-1

"The commenter states that the project should not provide potable water to the public unless the project site is annexed to the Garberville Sanitary District (GSD), which would provide potable water. As discussed in Section 4.17, Utilities and Service Systems, of the DEIR, the project would have adequate supplies of potable water; thus, annexation to GSD is not necessary. The commenter repeats the flow mitigation measures included in the DEIR as a possible condition for future GSD water use. Since these mitigations are already included in Mitigation Measure BIO-5, there is no need for the project to connect to GSD to follow these diversion limits. Lastly, the commenter presents a concern about future connection to the GSD sewer system. The project does not include a proposal to connect to the GSD sewer system."

(c) Re: LETTER C6 Saxton & Associates C6-21

"Annexation to GSD has not been proposed as part of the project and was not included as a mitigation measure because it was found that adequate water could be provided to the site without annexation. If annexation were to occur at a future date, further environmental review may be required. See the responses to Comments B3-1 and B4-1 regarding annexation to GSD and comments submitted by the Humboldt Local Agency Formation Commission (LAFCo) and GSD."

6. As stated, there was no review, study, mitigation or findings that disclosed or discussed using a metered water connection from GSD in conjunction or included within the SHCP EIR project or property. And or what direct or indirect effect it would have on the environment. Nor does the Final SHCP CEQA EIR disclose, discuss or analyze the past or future existence of potable water provided by either the Garberville Water Company (past) or GSD (future) and was NOT considered by the Planning Commission or Humboldt County Board of Supervisors through the Humboldt County

General Plan Amendment process. By what method did the GSD Board surmise that this new water connection was included in the Parks EIR? Answer, they did not.

7. Included in the addendum (Exhibit "E") every one of those 25 pages of mitigation measures are from the SHCP EIR (SCH# 2010092037), not the GSD IS/MND Annexation (SCH # 2012032025). If that is not "piecemealing". I don't know what is.

8. The SHCP was excluded from the GSD Annexation IS/MND process, from which this addendum was conceived and created. But yet GSD is now using this same GSD Annexation CEQA IS/MND the SHCP was excluded from to now be included without being annexed 6 years after the fact, with no rhyme or reason, other than they did not include this same information into the SHCP EIR.

9. If GSD and Humboldt LAFCo are going to "piecemeal" this addendum by using two different CEQA documents from two different projects with two different lead agencies and combine them into one, where is the addendum to the SHCP EIR (SCH# 2010092037)! Answer, they did not require one.

10. And I would like to dispute what was stated by GSD in their opening remarks (first paragraph page 1) and cover letter submitted with this Change Petition, where it states, in part:

"At one time this property was a GSD water customer, but was not within our Place of Use. Service to the property was discontinued and we would now like to reinstate it."

Please see Attachment 1, included in my protest packet. It includes detailed information of the extent of what GSD is referring to as a *"one time...GSD water customer"*. In fact, the truth is the SHCP illegally tied into a nearby potable waterline, without notifying GSD of its connection and water use. The reason they were originally included in the GSD Annexation process was to be included into the GSD jurisdictional boundary, place of use and have a legal water connection from GSD. However, for reasons that are not abundantly clear or were never publicly disclosed, GSD excluded the SHCP from the Annexation process (as stated above from item 5(a)), and remained outside the GSD SWRCB-DWR POU and jurisdictional boundary with no legal water connection.

11. As stated in the Response to Comments, Garberville Sanitary District Annexation Project SCH # 2012032025 (see Attachment 2), it states, in part from item 1:

"The IS/MND acknowledges the history of the SHCP connections on pages 4 and 5. Even though the goal of the project is to update the Humboldt Local Agency Formation Commission (LAFCo) approved jurisdictional boundary (boundary) and State Water Resources Control Board (SWRCB) Place of Use (POU) with the areas of historical water service provided by GSD or Garberville Water Company (GWC), the annexation area at the SHCP has been removed from the project. Any future changes or requests by the SHCP will be considered at that time. Additionally, the GSD took action on October 9, 2012, to provide conditions to be applied to an approval of any future annexation application for the SHCP. This is described on pages 23 through 26."

And item 2:

"Throughout the IS/MND, the impacts of the future SHCP project are discussed in the context of the potential for cumulative impacts within the proposed annexation area in conjunction with this annexation project to the extent that the SHCP project pertains to that impact topic."

The key words in this characterization are *"discussed"* and *"potential"*, not addressed, analyzed, studied or mitigated. The question(s) should be; did the SHCP expand or increase its scope, sheer size, development and increased water demand where the SHCP NOP or GSD Annexation IS/MND left off (2010/2013) as stated in item 2? Answer, YES, by a considerable amount!

And since the SHCP DEIR/FEIR expanded its project beyond what was denoted during the SHCP NOP (2010) and again to GSD in 2013 by the lead agency (Humboldt County), were these new impacts and effects to the environment addressed, analyzed, studied or mitigated in conjunction with the GSD Annexation IS/MND? Answer, NO!

And why is that, because as stated in item 1, *"the annexation area at the SHCP has been removed from the project. Any future changes or requests by the SHCP will be considered at that time."*

So, besides piecemealing this Addendum together between the GSD Annexation IS/MND and SHCP EIR, what was "considered"? Answer, nothing. Because nothing was addressed, analyzed, studied or mitigated under CEQA for the SHCP to have and use potable water from GSD. And as we know, this Addendum did not include or authorize the SHCP property be annexed into the GSD jurisdictional boundary by the Humboldt LAFCo Commission.

In closing, I would like to remind the Division of Water Rights the South Fork Eel River is a Wild & Scenic River, both state and federally listed. In the 26 years I have tried to protect the South Fork Eel beneficial uses, I have never seen such a blatant disregard of the public trust as I have witnessed and read in this Petition and CEQA Addendum. For this reason and including my public comments I included for both the GSD Annexation IS/MND (SCH # 2012032025) and SHCP EIR (SCH# 2010092037), I would request you deny this Petition as stated until such time as this project can be analyzed under a standalone CEQA initial study process. Only then should this Petition move forward for the State Water Boards approval. If not, I will consider my options and right to keep defending the South Fork Eel Rivers beneficial uses which include essential fish habitat for threatened and endangered aquatic species, and reason for its inclusion and protection under the state and federal Wild & Scenic Rivers Act.

GENERAL OVERVIEW

Since the last board meeting the following tasks have been completed:

- 1. Received back the Notice of Exemptions with no challenge filed.
- 2. DWSRF project manager assigned and I have begun coordination. It will probably be six months before we receive any specific information regarding moving forward with a funding agreement.
- 3. The DWSRF project manager inquired about combining the projects to streamline funding and execution, so we combined the two tank projects and left the aerial waterline as a separate project.

I was notified via email by FAAST that "Small Community Funding Program, Pre-Application is currently accepting applications from 11/21/2019 8:00:00 AM through 6/30/2025 5:00:00 PM via the Financial Assistance Application Submittal Tool (FAAST)." If the Board desires, we can investigate the possibility of applying for this program for these three projects.

FINANCIAL CONSIDERATIONS

Any cost associated with preparing additional applications will be minimal compared to the initial cost of getting all the documentation together. A significant portion of the budgeted \$20,000 remains available to cover these costs.

STAFF RECOMMENDATION FOR BOARD ACTIONS

Direct staff to research new funding program and prepare applications if the projects are eligible.

Sec 9.5 <u>Payment of Bills.</u> Bills are due and payable by 4:30 P.M. on the 25th of each month and if not paid a <u>\$15</u> late charge will be applied.

- a. Customer Bills: Bills will be mailed by the first of each month.
- b. Late Payments Procedure:
 - (1) Bills past due Courtesy Call
 - (2) 35 days past due Shut off notice Hand delivered to service address.
 - **Owner or Property Manager Notified**
 - (3) 7 days after shut off notice is delivered Water will be turned off. Owner will be notified. There will be a \$100 reconnection fee due, prior to water reconnected.
 - (4) 60 days One Year past due Lien on building/property File Small claims against owner/customer for service charges owed with associated fees and late charges plus \$500 for staff time and legal expenses.
 - (5) 120 days Two Years past due Turn over to collection agency.
 - (6) 2 years of non-payment, meter will be removed and owner and property manager notified that a new water and sewer connection fee will be due before water reconnected.
- Adjustments to bills Payment Plans: The General Manager or designee will be the only person authorized to make adjustments to a bill or enter into a payment plan.
- d. NSF (non-sufficient funds) from any payment source will require the customer pay all bank charges and a \$35 handling fee.
- e. Upon 2 NSF (non-sufficient funds), within a 12-month period automatic payment will be denied until an agreement can be reached with the General Manager or designee.
- f. Tampering with water meters or turning meters on after being turned off for nonpayment may result in a customer fine of \$200 and a reconnection fee of \$100 which must be paid with all outstanding service charges before water will be turned on unless an agreement is made with the General Manager or Designee.
- g. Service Charge Discount may be available for any customer that verifies they are over the age of 62 and have a combined income of less than \$24,000 annually. Customers who qualify may receive a \$15 credit which can be used to decrease their monthly service charge. Any service credit will require (10) units (7,500 gallons) in a given month, the service charge discount will be voided for that month.

Sec 9.6 <u>Billing of Separate Meters.</u> Separate bills will be rendered for each meter installation.

Sec 9.7 <u>Customer's Guarantee</u>. The water charge begins when a service connection is installed and the meter is set. The property owner must sign the customer service agreement form prior to being connected. This agreement guarantees that the owner is responsible for their property and for all unpaid service charges.

- a. Customers are required to place a deposit of \$100, refundable or applied to account after 2 years of good payment history.
- b. Owner will be responsible for any unpaid charges. Account must be current before

customer's account can be established.

c. Failure to receive a bill does not relieve consumer of liability. Any amount due shall be deemed a debt to the District and any person, firm, or corporation failing, neglecting, or refusing to pay said indebtedness shall be liable to an action in the name of the District in any court of competent jurisdiction for the amount. LATE PAYMENT CUSTOMER PROCEDURES

As we have worked diligently to bill customers at same time each month, give friendly reminders, give late charges, personal notices for timeline and shutoff, we are still having customers who disregard the monthly service charges and fees.

There are some who have had their water turned off for months and still do not contact us for a payment plan. We have discussed this internally because at what point do we file a lien on the property or take these customers to small claims court?

We have a very specific policy which states what is required and what actions we can take but have learned that if we file a lien or go to small claims court, we have to use a specific dollar amount we are owed, while any other accrued charges while waiting for judgement or house to sell, are not included.

The other concerning factor is that the time it takes and the fees required to pursue liens and small claim judgements is costly so we would like to discuss at what point should we pursue these or other options to collect the money owed?

Sec 4.9 <u>Service Connection</u>. It shall is be unlawful to install a well without GSD approval, or use a water connection that does not conform maintain a connection excepting in conformity with the following rules:

- a. Multiple service connections for single parcel are allowed under these conditions, if approved by General Manager or designee:
 - 1. Each building under separate ownership must be provided with a separate service connection and meter. Two or more buildings under same ownership and on the same lot or parcel may be supplied through the same service connection and meter if approved by the General Manager or designee.
 - 2. A master meter is installed at the property line.
 - 3. Metered service connections are provided for each sub unit or single family residence. Meters and valves will be supplied and remain property of GSD.
 - 4. Supply line from master meter to each of the units shall be installed and maintained by owner.
 - 5. Owner will be responsible for usage on master meter, determined by deducting each sub unit from master meter.
 - 6. Owner will be responsible for notifying the District of any changes to property or buildings at such time the General Manager or designee will inspect property for compliance of District service connection ordinances.
 - 7. Failure to notify the District when making improvements to the property or buildings may result in inspection costs and reimbursement of staff time, meters and construction expenses along with applicable connection fees.
- b. Different Owner. A service connection shall not be used to supply adjoining property of a different owner or to supply property of the same owner across a street or alley.
- c. Divided Property. When property with a service connection is divided, each parcel will have a separate service connection. Change to exiting services is also subject to but not limited to Sections 2.6 and 4.4. Adopted 03/28/2017
